Introductions and welcome new members.

### **Principal Updates – Emily:**

- Updated Franklin values: Safe Body, Kind Heart, Thinking Mind.
- Shared photos of the first week of school
- Start of the school year is focusing on building relationships and learning routines

## **Principal Updates – John:**

- Staff building events prior to school starting
- Shared photos of the first week of school
- School improvement target areas: reading proficiency, belonging / relationships, attendance

#### Class sizes:

Discussion on class sizes, board policy, when to add another section to a grade.

- Class size determination starts in winter to project for the following year
- Many factors are considered including birth rates, housing trends, prior year enrollment
- Principals monitor class size numbers and advocate for extra sections if needed
- Every year there is a "3rd Friday Count" that occurs on the third Friday in September. This is to assess class sizes and teachers/resources may be moved if numbers necessitate it
- Class sizes are determined by the district and maximum class size numbers are nationally accepted as standard
- This year, sections added for K and 1st Grade, for a total of 5 sections per grade. Kindergarten class sizes are around 18. First grade is around 19.
- Largest class size at Randall is currently 27

### 2024/25 Budget:

Overview of this year's budget and changes from prior year:

- increased social justice fund
- increased parking revenue and expense (extra port a pot)
- added Reflex Math (Randall) and Lexia (Franklin)
- reduced PEG coordinator stipend to avoid 1099 filing requirements
- eliminate computer repair fund
- lowered administrative costs

Need to move \$1066.15 for Franklin LMC to prior fund from playground fund due to error. Lisa motions to move LMC money, Ashley Russell seconds, motion approved.

## 25<sup>th</sup> Anniversary Garden Event – Anne Reis & Erika Anna:

- Considering hosting fall fundraiser for the Randall garden on Sept 28th or October 12<sup>th</sup>.
  Decided on October 12<sup>th</sup>.
- Time options: 1pm-4pm or 1:30pm-4:30pm
- Event ideas: fall harvest stations, garden tours, focus on nutrition, donate to "buy" a canvas bag of fall fruits and veggies

## Screenagers event – Mickey:
